





Prime Responsibilities of the POCSO Committee in a School

1. Ensure Child Safety

- Create a safe, supportive, and abuse-free environment in the school.
 - Prevent any form of child sexual abuse—whether physical, emotional, or online.
-

2. Awareness & Orientation

- Conduct regular awareness sessions for students, teachers, and non-teaching staff on:
 - What constitutes sexual abuse
 - Good touch vs bad touch
 - How to seek help
 - Include awareness in the school's curriculum or co-curricular activities.

3. Establish and Maintain a Child Protection Mechanism

- Form a POCSO Committee with designated members (Principal, senior teacher, female staff member, counselor, parent representative).
 - Display the committee details on the school noticeboard and website.
-

4. Reporting & Redressal

- Ensure a confidential and accessible mechanism for students to report abuse or misconduct.
 - Take immediate and appropriate action on any complaints.
 - Inform the local police or child welfare committee within 24 hours if a POCSO violation is suspected.

5. Support to Victims

- Provide emotional and psychological support to victims through counseling.
 - Ensure the victim is not further traumatized during investigation or inquiry.
-

6. Maintain Records

- Keep detailed and confidential records of complaints, actions taken, and outcomes.
 - Share reports with authorities if required during audits or inquiries.
-

7. Regular Monitoring

- Periodically review safety measures in place (e.g., CCTV, restricted access areas).
- Ensure all staff have undergone police verification and signed a child protection code of conduct.
